INSPECTED GENERATOR AND ENGINE. ENGINE HAS VERY LOW HOURS. FOUND NO ISSUES ON THE OUT SIDE OF THE ENGINE. NOTHING MISSING. PULLED VALVE COVER AND ENGINE INTERNALS HAVE NO RUST OF CORROSION INSIDE. PULLED AIR INTAKE AND IT WAS CLEAN NO CORROSION OR THERE IS SOME RUST ON THE OUTSIDE BUT THE UNIT SPENT ALOT OF TIME AT THE COAST. NO COOLANT IN ENGINE BUT FROM WHAT I COULD SEE NO RUST. INSPECTED THE GENERATOR AND THE GENERATOR IS CLEAN WITH NO DAMAGE OR CORROSION TO THE WINDINGS OR INSULATION. OVER ALL THE ENGINE AND GENERATOR LOOK TO BE IN GREAT SHAPE VISUALLY.
